About Our Privacy Policy

This Privacy Policy is designed to help you understand how we including the website located at <https://beta.acetrader.com> (the “**Website**”, “**We**”, “**Us**”, and “**Our**”) collects, uses, and shares your personal information and to help you understand and exercise your privacy rights.

When you use our Website, you’ll share some information with us. We want to explain clearly what information we collect, why we collect it, how we use it, whom we share it with, and the controls we give you to access, update, and delete your information.

Much of the information on the Website is public and accessible to everyone, with or without an account. By using the Website, you are directing us to share this information publicly and freely.

When you submit content to the Website, any users of our Website will be able to see that content, the username or display name associated with the content, and the date and time you originally submitted the content. That content and information may also be available in search results on Internet search engines such as Google or in responses provided by an AI chatbot like OpenAI’s ChatGPT. You should take the public nature of the Website into consideration before posting.

We may also offer social sharing features that let you share content or actions you take on our Website with other media. Your use of these features enables the sharing of certain information with your friends or the public, depending on the settings you establish with the third party that provides the social sharing feature.

How We Collect Information

Information You Choose To Give Us

When you use and interact with our Website, our Website collects minimal amounts of personal information from you, such as your contact information, email address, wallet address, and/or other transaction information. However, we will never ask you to provide or collect your private keys.

To make it easier for others to find you, we may also ask you to provide us additional information that will be publicly visible on our Website, for example a profile picture, a name, or other identifiable information. Lastly, when you contact us or communicate with us in any way, we'll collect any information you give us.

Information We Get When You Use our Website

When you use our Website, we collect information about how you use them:

Usage Information. We collect information about your activity through our Website, such as what pages, tags you look at, and what you search for.

Device Information. We also collect information from and about the devices you use, such as hardware model, operating system version, device memory, advertising identifiers, unique application identifiers, unique device identifiers, language, and information about your wireless and mobile network connections, such as your type of network connection.

Camera and Photos. Some of our features may require us to collect images and other information from your device's camera and photos.

Location Information. When you use our Website, we may collect information about your location. With your permission, we may also collect information about your precise location using methods that include GPS, wireless networks, and Wi-Fi access points.

Information Collected by Cookies and Other Technologies. We and our service providers or our third party partners may also automatically collect information from you when you use our Website through cookies and other tracking technologies. We may store some information on your device or device hard drive as a cookie or similar type of file (such as clear gifs, web beacons, tags, and similar technologies that work on mobile devices) to collect data related to usage of the Website. We may also use these

technologies to collect information when you interact with the Website we offer through one of our partners, such as advertising and commerce features. "Cookies" are pieces of information that may be placed on your computer by a website for the purpose of collecting data to facilitate and enhance your communication and interaction with that website. Such data may include, without limitation, the address of the websites you visited before and after you visited the Website, the type of browser you are using, your Internet Protocol (IP) address, what pages in the Website you visit and what links you clicked on, the region where your device is located, and geo-IP data. We may use cookies to customize your visit to the Website and for other purposes to make your visit more convenient or to enable us to enhance our Website. Removing or rejecting cookies may affect the Website's function and availability.

We may work with third-party service providers, such as Google, who use the technologies described in this section to conduct analytics to help us track and understand how visitors use the Website.

Log Information. We also collect log information when you use our Website. For example:

- Details about how you've used our Website.
- Device information, such as web browser type and language.
- Access times.
- Pages and content viewed.
- IP address.
- Identifiers associated with cookies or other technologies that may uniquely identify your device or browser.
- Pages you visited before or after visiting our Website.

Information We Collect From Third Parties

We may collect information from our affiliates and third parties, including through third-party services and organizations. For example, if you access our Website through a third-party application, such as an app store, a third-party login service, or a social networking site, we may collect information about you from that third-party application that you have made available via your privacy settings.

Our Website may offer various tools and functionalities that allow you to provide information about your friends through our referral service; third parties may also use these services to upload information about you. Our referral services may also allow you to forward or share certain content with a friend or colleague, such as an email inviting your friend to use our Website. Please only share with us contact information of people with whom you have a relationship (e.g., relative, friend, neighbor, or co-worker).

How We Use Your Information

We use your information to provide you with the best products and services we can build and improve. Here's what we use this information for:

- To develop, maintain, improve, deliver, and protect our products and Website.
- Monitor and analyze trends and usages of our products and Website.
- Send you communications, including by e-mail. Examples include using e-mail to respond to support inquiries, or to share information about our products, Website, and promotional offers that we think may interest you.
- Personalize our Website by showing you better and more relevant content.
- Provide ad targeting and measurement, including the use of your precise location information to show relevant ads.
- Enhance and enforce the safety and security of our products and Website.
- Verify your identity and prevent fraud, or other unauthorized and illegal activity.
- Use information we've collected cookies and other data to enhance our Website and products.
- Enforce our Terms of Service and other usage policies.

How We Share Information

We may share information about you in the following ways:

With other Users. We may share information with other Website users. Examples include:

- Information about you, such as your display name, username, and profile pictures.
- Information you upload, such as text, image or video posts.
- Information we collect and publicly available from the crypto wallet address(es) you provided.

With all Users, our business partners, and the general public. We may share information with all Website users, our business partners, and the general public. Examples include:

- Public information like your display name, username, and profile pictures.

- Content from our Website that you share on other Website, such as Facebook or Pinterest.

With our affiliates. We may share information with the entities within the Memeland ecosystem and family of companies.

With other third parties. We may share your information with third parties. Examples include:

With service providers. We may share information about you with service providers who perform Website on our behalf.

With third parties for legal reasons. We may share information about you if we reasonably believe that disclosing the information is necessary. Examples include:

To comply with any valid legal process, governmental request, or applicable law, rule or regulation.

To investigate, enforce, or remedy potential Terms of Service violations

To protect the safety, rights, and property of the Website, our users, or others.

To detect and resolve any fraud or security matters or concerns.

With third parties as part of a merger or acquisition. If the company gets involved with a merger, asset sale, financing, liquidation, bankruptcy, or acquisition of all or some portion of our business to another company, we may share your information with the company before, during, and after the transaction.

We may also share aggregated, non-personally identifiable, or de-identified information with third parties, such as advertisers.

For the avoidance of doubt, due to the public nature of the blockchain, any information about your transaction you enter onto the blockchain could possibly be used to identify you or information about you, and this Privacy Policy does not apply to information on the blockchain as a result of, but not limited to, creating, minting, collecting, swapping, trading and transferring a digital asset which will be publicly accessible and outside of our control.

Third-Party Content and Integrations

Our Website may contain third-party links and search results, include third-party integrations, or offer a co-branded or third-party-branded-service. Through these links,

third-party integrations, and co-branded or third-party-branded Website, you may be providing information, including personal information, directly to the third party, to us, or to both. You acknowledge and agree that we are not responsible for how those third parties collect or use your information. We encourage you to review the privacy policies of every third-party service you visit or use, including those third parties you interact with through our Website.

Analytics and Advertising Website

Provided by Others

We may let other companies use cookies, web beacons, and similar technologies on our Website. These companies may collect information about how you use our Website over time, and combine it with similar information from other websites and companies. This information may be used to analyze and track data, determine the popularity of certain content, and under your online activity, among other things.

Some companies, including our affiliates, may use information collected on our Website to measure the performance of ads and deliver more relevant ads, including on third-party websites and apps. When you enter your email address on our website (either to log in, or to sign up to a newsletter, or similar) we may share personal or other information that we collect from you, such as your email (in hashed, pseudonymous form), IP address, or information about your browser or operating system, with these companies. These companies may use this information to create an online identification code for the purpose of recognising you on your devices. This code does not contain any of your identifiable personal data and will not be used by those companies to re-identify you. We place this code in our first party cookie and allow it to be used for online and cross-channel advertising. It may be shared with our advertising partners and other third party advertising companies globally for the purpose of enabling interest-based content or targeted advertising throughout your online experience (e.g. web, email, connected devices, and in-app, etc). You have the right to withdraw your consent or opt-out to the processing of your personal data at any time.

Provided by Us

We may collect information about your activity on third-party websites that use cookies and other technologies provided by us. We use this information to improve your user experience with our Website and to improve our advertising services, including measuring the performance of ads and showing you relevant ads.

How Long We Keep Your Information

The Website stores your information, for example:

- We store your basic account information, including your name, username, and email address, wallet address, social handles, etc until you ask us to delete them.
- We store location information for different lengths of time based on how precise it is and which feature or service you use.
- We are constantly collecting and updating information about the things you like or dislike, so we can provide you with more relevant data, more relevant ads, and a better user experience.

There may be legal requirements to store your data and we may need to suspend those deletion practices if we receive a valid legal process or request asking us to preserve that content, or if we receive reports of abuse or other Terms of Service Violations. We may also need to retain certain information in backup for a limited period of time, or as required by law.

Control over Your Information

At our Website, your privacy is important to us. We want you to have control over the information you give us, the information we use, and the information we keep. Our Policy on Children's Information

Revisions and Changes to the Privacy Policy

Bases For Using Your Information

Your country only allows us to use your personal information when certain conditions apply or are met. These conditions are called legal bases. At our Website, we rely on one of the following bases:

Contract. We may use your information because you've entered into an agreement with us.

Legitimate Interest. We may use your information because we - or a third party - has a legitimate interest. For example, we need to use your information to provide, maintain and improve our Website. This includes protecting your account, providing customer support, and showing the best content you'll like. Most of these services are free. To keep the lights on at our Website, we may use this information to show you relevant ads. We believe legitimate interest does not outweigh your right to privacy, so we only rely on legitimate interest when we think the way we are using your data does not significantly impact your privacy.

Consent. We may ask for your consent to use your information for specific purposes. If we do, we'll make sure you can revoke your consent in our Website or through your device permissions at any time. Even if we're not relying on consent to use your information, we may ask you for permission to access data such as your location.

Legal obligation. We may use your personal information when we are required to comply with the law, such as when we respond to a valid legal process or need to take action to protect our users or employees.

Your Right To Object

International Transfers

We may collect your personal information from, transfer it to, and process it in the United States and other countries outside of where you live. When we share information of EU and EEA users outside the EU or EEA, we make sure an adequate transfer mechanism is in place. For international transfers, we rely on Data Process and Security Terms (DPST), EU Model Contract Clauses (MCC), and Standard Contract Clauses (SCC).

Your Right To Complain

The Personal Information That We Collect About You

For individuals who are California, Virginia, Connecticut, or Colorado residents, the California Consumer Privacy Act (“**CCPA**”), Virginia Consumer Data Protection Act (“**VCDPA**”), Connecticut Data Privacy Act (“**CTDPA**”), and the Colorado Privacy Act (“**CPA**”) requires certain disclosures about the categories of personal information we collect and how we use it, the categories of sources from whom we collect personal information, and the third parties with whom we share it with.

Depending on how you interact with us, the Website may collect the following categories of information as summarized in the table below. This does not apply to personal information we collect from employees or job applicants in their capacity as employees or job applicants. It also does not apply to personal information we collect from employees, owners, directors, officers, or contractors of businesses in the course of our provision or receipt of business-related services.

Categories of Business/Commercial Purposes for Use of Your Information

All of the categories of personal information we collect about you (as detailed above) are used for the following purposes:

- Providing our services (for example, account servicing and maintenance, customer service, advertising and marketing, analytics, and communication about our)
- For our operational purposes, and the operational purposes of our service providers and integration partners
- Improving our existing services and developing new services (e.g., by conducting research to develop new products or features)
- Delivering relevant advertising
- Detecting, protecting against, and prosecuting security incidents and fraudulent or illegal activity
- Bug detection, error reporting, and activities to maintain the quality or safety of our
- Auditing consumer interactions on our site (for example, measuring ad impressions)
- Other uses that advance our commercial or economic interests, such as third party advertising
- Other uses that we notify you about

California, Virginia, Connecticut, and Colorado Rights and Choices

Subject to certain restrictions, California, Virginia, Connecticut, or Colorado residents have the right to request that we disclose what personal information we collect about you, to delete any personal information that we collected from or maintain about you, and to opt-out of the sale of personal information about you. As a California, Virginia, Connecticut, or Colorado resident, you also have the right to designate an agent to exercise these rights on your behalf. This section describes how to exercise those rights and our process for handling those requests, including our means of verifying your identity. Accessing and Deleting Your Personal Information

Right to Request Access to Your Personal Information

California, Virginia, Connecticut, or Colorado residents have the right to request that we disclose what categories of personal information that we collect, use, or sell about you. You may also request the specific pieces of personal information that we have collected about you. However, we may withhold some information where the risk to you, your personal information, or our business is too great to disclose the information.

Right to Request Deletion of Your Personal Information

You may also request that we delete any personal information that we have collected from/about you. However, we may retain personal information as authorized under applicable law, such as personal information required as necessary to provide our , protect our business and systems from fraudulent activity, to debug and identify errors that impair existing functionality, as necessary for us, or others, to exercise their free speech or other rights, comply with law enforcement requests pursuant to lawful process, for scientific or historical research, for our own internal purposes reasonably related to your relationship with us, or to comply with legal obligations. We need certain types of information so that we can provide our services. If you ask us to delete it, you may no longer be able to access or use our .

How to Exercise Your Access and Deletion Rights

California, Virginia, Connecticut, or Colorado residents may exercise their privacy rights by contacting us at as set forth in [Contact Us](#).

For security purposes, we may request additional information from you to verify your identity when you request to exercise your California privacy rights.

If you have an online account with us, logging into your account will serve to verify your identity and request, although we may request additional information if we believe your account has been compromised. If you do not have an account with us, or if we have reason to suspect that the security of your account is compromised, we will request additional information from you to match with our existing records to verify your identity, depending on the nature of the request and the sensitivity of the information sought.

Once you submit a request to (1) access the categories of personal information we have about you or (2) obtain a copy of specific pieces of personal information we have about you, we will ask that you verify your identity by logging into your account. If you don't have an account with us, we will ask you to provide certain information so we can verify your identity. Once verified, we will provide you access to your information in a downloadable format.

To request that we delete personal information we have collected from you, you will need to authenticate with us by first logging into your account.

If you wish to exercise any of these rights and do not have an account with us, please contact us as set forth in [Contact Us](#) and we will request additional information to perform identity verification where possible.

Sales of Personal Information
